#### **Application Instructions**

- 1) Review and complete the one page form below, **signing** where indicated.
- 2) Submit a scanned copy to ICLEI USA at riana.ackley@iclei.org
- 3) ICLEI will review applications on a rolling basis as received; funds will be provided on a first-come basis while available.
- 4) The scholarship amount will be up to \$1000 per GMVR. Priority will be given to those that are not receiving travel assistance from another source, and plan on attending the International Energy Conservation Code (IECC) portion of the hearings (Oct 19-22.)

#### **Terms and Conditions**

- 1) ICLEI USA is providing travel scholarships to local governments for the express intent of enabling qualified local government officials (GMVRs) to attend the ICC Final Comment Hearings in Kansas City, MO, October 19-25, 2016. While the travel scholarship is intended to partially cover expenses of the individual traveler, the expense reimbursement payment will be made only to the local government (i.e. the traveler's employer.) Membership in ICLEI USA is not required to apply for travel support.
- 2) By signing below, the elected governing body representative or chief administrative officer agrees that:
  - a. The jurisdiction is a current member the International Codes Council.
  - b. The jurisdiction has reviewed *Compliance with ICC Policies* and will comply with all ICC policies, especially CP36-09, Financial Assistance.
  - c. Acceptance of travel support is **not** contingent on support for sponsors' positions and there is no expectation of favorable voting in return for travel support.
  - d. Travel assistance is provided only to allow local government officials to participate in code development hearings.
  - e. Acceptance of this travel scholarship will comply with all local policies for accepting financial support from outside organizations.
  - f. Acceptance of this travel scholarship will comply with all local travel policies and applicable law.
  - g. The jurisdiction will comply with all ICLEI policies and instructions for receiving travel scholarships and reimbursement or risk forfeiting this financial assistance.
- 3) Reimbursement of expenses directly to individuals is prohibited by ICC policies and rules. ICLEI will only make scholarship payments to ICC governmental members (e.g. local jurisdictions). Local governments then pay for travel expenses or reimburse their delegates.
